There is one large mature horse chestnut tree at the foot of the garden of 19 Queens Road which has previously been thinned out and also reduced and now I'd like to have the crown lifted to allow more light into the garden as indicated on the attached 'crown-lifting.jpeg' and also 'site-plan.jpeg'

Also, I've spoken with a few tree surgeons about this tree as it's disproportionately large for it's location but they defer to the council as to what would be the best course of action for this tree in the future and so I'd welcome a chat with a council specialist as to what and when things needs to happen in the future.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
