Latrol roots have been lifting up the pavind in all sarounding gardens caushing a trim hazard Client suffers from hay fever from the pollen from the tree in the summer

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
