Details of the pre-application advice received

Pre-Application Advice Summary

The proposal seeks to replace the existing single-storey rear extension with a larger structure that extends across the full width of the property and partially down both sides. While there is no objection in principle to this approach, the design must remain subservient to the host property. To achieve this, the extension must sit below the first-floor windows, as stipulated in local design guidance. Currently, the southern section is set too high and will need to be lowered.

A first-floor rear extension is also proposed, spanning part of the rear and side of the property. However, this element raises significant concerns. The local House Extensions SPD recommends that two-storey extensions should be less than half the width of the original dwelling, a standard that the proposal does not meet. Furthermore, the hipped roof design does not integrate well with the existing roof slope and fails to appear as a natural continuation of the property. As a result, the extension appears overly dominant and would constitute overdevelopment of the site.

The two-storey side extension follows some of the design guidance, including being set back at least one meter from the front elevation. However, like the first-floor rear extension, its width exceeds half that of the original property, which is contrary to local policies.

In summary, while there are no fundamental objections to extending the property, revisions are necessary to ensure the extensions are scaled appropriately, remain subordinate to the host building, and align with the character of the area. The reductions to the width and height of the proposed extensions would help address these issues and bring the scheme closer to compliance.
