Front Garden (Right Boundary)

T1: Laurel tree (located in mixed hedge) - Fell to ground level (stump remaining)

height 4m & spread 3m. Reduce height to 0m & spread to 0m

(Left Boundary)

T3: Small privet tree (located next to house) – Fell to ground level, dig or grind out stump height 1m & spread 1m. Reduce height to 0m & spread to 0m

T4: Elaeagnus shrub – Fell to ground level, dig or grind out stump height 3m & spread 2m. Reduce height to 0m & spread to 0m

(Front Boundary)

T5: Ash tree – Re-prune by 1.5 - 2m to stand around 0.5 - 1m from previous pollard points, remove major deadwood, lfit caopy to 5.5m over road side

height 10m & spread 7m. Reduce height to 8m & spread to 5m

Back Garden (Left Boundary)

T7: Mock orange tree – Reduce height by 1m height 4m & spread 4m. Reduce height to 3M & spread to 3m

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
