Back Garden (Left Boundary)

T1: Yew tree – Lift canopy to 1 - 1.5m above fence, reduce height by 2 - 2.5m through selective thinning leaving a Holistic crown reduction , reduce sides by 1 - 1.5m through selective thinning leaving a Holistic crown reduction, thin canopy by 5%

height 8m & spread 6m. Reduce height to 6m & spread to 5m

The reason for the work is to reduce the size of a tree located in the back left hand side of the garden. The tree has grown very large for the area it is in, and the client wants to keep it but reduce its size.

This is also necessary because the tree is located in close proximity to two garden boundary walls, and the trunk growth and roots could potentially damage these structures.

It is causing excessive shading to surrounding shrubs. By reducing its size, we will be able to allow more light into the surrounding gardens and promote the growth of the other plants. This will also create a more balanced and aesthetically pleasing area in line with the neighbouring gardens.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
