Back Garden (Left Boundary) T2: Privet shrub – Clear from building by 0.5m height 3 & spread 3m. Reduce height to 3m & spread to 2.5m

T3: Holly tree – Fell to ground level, install specialist poison to kill stump and prevent regrowth (stump remaining) height 4m & spread 2m. Reduce height to 0m & spread to 0m

(Back Boundary)

T4: Beech tree – Reduce height by 1m, reduce sides by 1m to balance, remove major deadwood height 4m & spread 4m. Reduce height to 3m & spread to 3m

(Right Boundary) T7/T7A: Sorbus tree x2 – Reduce height by 0.5m height 4m & spread 4m. Reduce height to 3.5m & spread to 3.5m

T8: Dead cherry tree – Fell to ground level (stump remaining) height 3m & spread 1m. Reduce height to 0m & spread to 0m

T11: Viburnum shrub – Prune by 1m height 3m & spread 2m. Reduce height to 0m & spread to 0m

Reason for work General tree maintenance More light clearance from building maintaining this tree in its current setting Dead tree t8 suppressing growth of shrubs t3

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
