The proposed development is to remove the existing breezeblock wall and piers bordering the public footpath outside the front of the house as well as removing the crazy paving and pathway outside the property. The space would then be levelled off and bricked over to create a permeable parking space for one car. The path leading to the front door would also be replaced with a permeable brick.

On the right hand side of the front garden a new bin storage for the two flats would be constructed to allow for tidy and discrete storage of their recycling bin.

The previously removed wall and piers would be replaced where necessary with London brick walls and piers to tie in with the front wall of number 12.
