432 - Silver Birch

Lowest, over extended, end-weighted lateral growing towards pub car park over shed, reduce back to 3m stub, retaining small diameter, off shoot live limb arising from historically cut branch.

Secondary crown lift to 5m of lowest, small branches hanging over car park entrance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
