G22a Mixed Species Crown Lift to provide 4m clearance from ground level. Final height unchanged at 15m and final spread unchanged at 8m.

  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
