G1 Lime - 2 x Lime trees - To crown lift both trees to 7m by removing all epicormic growth to allow the security camera to see the gate on the opposite side of the road. This work is essential maintenance for the water works security.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
