For the avoidance of doubt the drawing numbers to which this decision refers are as follows:- 3808 received on 13 February 2007.

## Reason for granting:

The proposal has been considered in the light of the Development Plan, comments from statutory consultees and third parties (where relevant) and compliance with Supplementary Planning Guidance as appropriate. It has been concluded that there is not a demonstrable harm to interests of acknowledged importance caused by the development that justifies withholding planning permission. The proposed development would not result in an overbearing impact, or loss of light, outlook or privacy to neighbouring properties, and would not detract from the character and appearance of the building or the surrounding area.

You are recommended to prepare a survey, including photographs, of the condition of the adjacent public highway, including pavement, which should be sent to the Local Highway Authority prior to the commencement of work to ensure that damage to the highway is prevented or repaired. Otherwise you and/or your contractior, may be held responsible for any damage found on completion of the works.
