#### **DELEGATED REPORT**

Site Address: Latchmere House, Church Road, Ham

Reference: 07/2477/FUL

Policies: BLT 2, 11, 15 and 16, ENV 1, 11 and 18.

**Site/Surroundings:** Latchmere House is a large, detached building within the remand centre grounds. Despite its appearance, the property is not listed, nor a BTM but is within the Ham Common Conservation Area. It is adjacent to Ham Common – designated as MOL, OSNI and POS. There are several TPO'd trees in the grounds.

**Proposal:** Erection of satellite dish to roof of a boiler roof building. The dish would have a diameter of 1.8m.

Relevant History: See file for recent history.

**Representations:** One letter of objection received raising issues about the siting of the dish (and the harm to views of the prison) and the use of dish to provide television channels (with increase in noise from the prison) and use of tax payers money.

Once the need for the dish had been described, and the website plans pointed out to the writer, the objection was withdrawn, providing the dish is only to be used for communication purposes (and not tv). No Committee request was made.

**Professional comments:** The proposal would not be prominent in public views due to its distance off the boundary and screening by other buildings and the perimeter wall. It is therefore considered to at least preserve the character and appearance of the site and of the Conservation Area. It would not affect the amenity of surrounding properties, nor the adjacent MOL, POS or OSNI due to its small nature and screened location.

It is not reasonable (nor probably enforceable) to condition the dish to only to be used for communication purposes (rather than TV). It does not necessarily follow that were the dish to be used for TV that it would cause any additional harm to the character of the area, neighbour amenity etc anyway.

Recommendation: Approve

Conditions: Three years

**Informatives:** The proposal would at least preserve the character and appearance of the building and the Conservation Area. It would not harm neighbour amenity, nor the character of the adjacent Metropolitan Open Land, Public Open Space and Other Site of Nature Importance.
